Organization constructed a cache of difficult to find items, toilet paper, paper towels, hand sanitizer, plastic gloves, and face masks for community distribution. The organization operated a drive through handmade mask distribution program in the early pandemic months. Starting late in 2020 the organization began an effort to create a drive through vaccine distribution for our served community; and much more.
